# SASA016 An introduction to social work research and practice (reading course; third cycle) 7.5 credits

## 1. Details of approval

This syllabus was approved by the School of Social Work's Department Board on 10 February 2022.

#### 2. General information

The course is an independent study third-cycle course within the social work main field of study. The language of instruction is Swedish or English.

#### 3. Learning outcomes

After completing the course, the doctoral student shall

- Demonstrate specialised knowledge of social work as a field of research and practice.
- Demonstrate advanced ability to independently reflect on the significance of the field of their own thesis and its relevance for social work.

#### 4. Course content

The course is an introduction to social work as a field of research and practice, and aims to advance knowledge of the subject's development, central traditions and perspectives. During the course, the doctoral student is also to review the positioning of their own thesis area and its significance for the subject of social work. The literature includes both classical works and newer texts.

# 5. Teaching and assessment

The course is conducted through independent study. The course examination is through papers and oral assessment.
