1. Details of approval

This syllabus was approved by the School of Social Work's Department Board on 8 February 2023

2. General information

The course is third-cycle reading course within the social work main field of study. The language of instruction is Swedish or English.

3. Learning outcomes

After completing the course, the doctoral student is to

- Display specialised knowledge of the history of social work
- Display specialised knowledge and the ability to reflect upon how this history has been studied
- Display advanced ability to independently reflect on how the area of their thesis has been analysed in a historical perspective

4. Course content

The course builds upon prior knowledge of studies of the practice and history of social work. It aims to improve understanding of both the history itself and how it has been studied, which entails reflections about how choices of material and perspective contribute to the writing of history. During the course, the doctoral student may/is to review how the area of their thesis has historically been studied. The literature includes both classical works and newer texts. The doctoral student chooses literature in consultation with the examiner.

5. Teaching and assessment

The course is conducted through independent study. The course examination is through papers and oral assessment.

For 2.5 credits, the first learning outcome is to be achieved through a written paper of around 5-7 pages.

For 5 credits, the first two learning outcomes are to be achieved through a written paper of around 10 pages.

For 7.5 credits, all three learning outcomes are to be achieved through a written paper of around 15 pages.

6. Grades

Grading scale of Pass/Fail.

7. Entry requirements

Admitted to a third-cycle programme in social work at the Faculty of Social Sciences, Lund University.
